2. **DECLARATIONS OF INTEREST**

All trustees declared a personal interest as Parish Councillors to Enborne Parish Council.

4 MINUTES FROM PREVIOUS POORS ALLOTMENT CHARITY MEETING

Trustees **RESOLVED UNANIMOUSLY** to confirm and adopt the Minutes of the Poor's Allotment Charity held between Monday 4 January 2021 and 4th May 2021.

5 **FINANCE**

Trustees **RESOLVED UNANIMOUSLY** to confirm the statement of account for year ending 31/03/2021 and the statement of Financial Transactions to date as both shown as Appendix 1.

6 UPDATE ON POORS FIELD SOLAR PROJECT

Cllr. Garrett reported that the trustees now know the size, location (within the field) and design of the proposed solar farm. There is a Public Consultation scheduled for Thursday the 23^{rd of} September in the Falkland Cricket Club Community Room. Leaflets have been circulated to households to advertise the public consultation along with information on the website and the facebook page.

Partners Calleva Community Energy will be present to discuss visual amenity, ecology, drainage. There is no full economic analysis as Calleva are still waiting for quotations from SSE, the grid provider for hook up costs. Once we have the details of the grid connection Calleva will have to decide if the project is

economically viable, the Charity Trustees will have to sign off on the feasibility study and then the proposals will have to go to West Berkshire Council for Planning.

7 CHANGING CHARITY TO A CHARITABLE INCORPORATED ORGANISATION (CIO)

Cllr. Garrett reported that the trustees asked Stephens Scown solicitors to advise on modernising the Governance of the Poor's Allotment Charity. The advice received was to change the Governance model to a Charitable Incorporated Organisation (CIO) and that to mitigate future conflicts of interest the Charity should no longer be managed exclusively by Parish Councillors.

The trustees further engaged Stephens Scown to help through the application process with the Charity Commission. The trustees are expecting for approval, a final draft application from Stephens Scown any day now. With the help of Stephens Scown, the trustees are preparing new Governance Documents, including a grants policy and business plan. The Poor's Charity will be renamed the Enborne Parish Field Charity. It will have up to 6 trustees who do not have to be Parish Councillors. The Enborne Parish Field Charity will own the Parish Field

Cllr Garrett also reported the key facts to having a Solar Panel Farm in the Parish.

2MW Enborne Solar PV array will:

- generate 2,500,000 kWh clean energy per year
- save over 450 tonnes of carbon emissions per year
- equates to electricity supply for c.700 average UK homes or c.240 average UK homes including 10,000 miles electric car charging each year
- lead to an increase in the diversity and abundance of broad-leaved plants, grasses, butterflies, bumblebees, and birds (Westmill Solar Farm research 2016)
- add to local energy security
- provide active learning environments for local schools and college students
