However there was no police attendance in this meeting, and will be raised again in the next Community Forum meeting planned for 29th October.

7. **SOLAR ENERGY PROGRESS**

On 8th August, Cllr. Garrent attended the SSEN Community Flex Open Forum in Didcot. Scottish and Southern Electricity Networks (SSEN) are working with National Energy Action (NEA) on a project where communities can receive payments for helping ease constraints on the local electricity network, as an alternative to upgrading cables and substations. Cllr. Garrent said SSE grants are available to the parish. After a full discussion, members of council agreed to carry out a viable study

in the parish to ask the residents thoughts about putting in Solar Panels. Cllr's. Garrett and Leeson said they would discuss drafting a proposal statement together for a public survey.
