The Councillors considered transportation and the management of horse manure. Cllr. James Cole in attendance advised Council to discuss this application with Cllr. Benneyworth as ward member for further guidance on the concerns raised. Cllr. Benneyworth previously dealt with this application.

After further consideration, it was decided to discuss the application with Cllr. Benneyworth before forwarding the final comments to the Planners. The Councillors agreed to Object on the issue of Road Safety Access onto the highway, clearly there are Health & Safety concerns for horse riders and vehicle drivers.

#### 21/01692/FULD - Oakdene, Andover Drove, Wash Water.

Proposed new dwelling on Land at Oakdene, including demolition of existing garage and extension of existing driveway at Oakdene.

After consideration, it was agreed to Object on the grounds that it is not an appropriate development for the plot, but an overdevelopment for the size of the plot. This proposed planning was refused on appeal in March 2020 and the only amendment shown in this application is an extra 1 metre of clearance. This is still not suitable and not in keeping with the character of the street.
