1 APOLOGIES FOR ABSENCE:

Cllr. Peter Tompkins and Ward members Cllr. Denise Gaines and Dennis Benneyworth sent their apologies.

2 DECLARATIONS OF INTEREST ON AGENDA ITEMS AND DECLARATION OF MEMBERS INTEREST FORMS

Cllrs. Garrett and Dibas raised a declaration of Interest on the planning application Land North of Spring Gardens. 23/01361 confirming that they were both Trustees of the Charity Field.

Cllr. Garrett also raised a declaration on planning application 23/01714 Land at Watermill Bridge.

As only 3 Parish Councillors were in attendance the declarations of interest made the Parish Council inquorate when considering these important items of business. The Clerk reported that she had received a request from both Cllrs. Garrett and Dibas asking the council to consider whether it should grant a dispensation under section 33 of the Localism Act 2011 and in accordance with its standing orders, this would permit those members to vote despite their interest. The dispensations were granted by Council members.

A member of the public asked if the use of land between Falkland Cricket Club and Enborne Lodge Lane could be discussed at the next meeting.

5 PLANNING SCHEDULE (Appendix 1)

23/01190/FUL Hill Farm, Boames Lane. Councillors support this application. **23/01899/FUL Land West of Pumping Station**. Councillors agreed to maintain the same Objection representation as previously submitted to WBC.

23/01303/FUL Vanners Farm. Councillors agreed to support this application.
23/01623/FUL Peregrine Studio. Councillors Supported on the basis that the mobile home is only temporary.

23/01361/FULMAJ Land of North of Spring Gardens (Solar Farm)

Some of the members of the public present opposed the Solar Farm planning application. Jane Grindey from Calleva Community Energy invited members to a meeting with Calleva to explain in more detail on the flooding issues and how the project will be managed. The members thanked Mrs Grindey and accepted. Cllr. Garrett also invited one member to his home to discuss the flooding concerns in more depth. Calleva were happy to circulate the ecology report to the members as the report had been blanked out on West Berkshire Council planning portal due to their policy controls.
